## CONSUMER REPLACEMENT PARTS WARRANTY

### LENGTH OF COVERAGE:

OE PARTS's replacement parts warranty is in effect for 12 months or 12,000 miles from the date the part is installed on the vehicle, or for the remainder of any applicable new vehicle warranty, whichever period is longer.

### WHAT IS COVERED:

The replacement parts warranty covers repair or replacement of any part sold by OE PARTS that is defective in material or workmanship and fails under normal use. Parts installed by an authorized new car dealer will be repaired or replaced without charge for parts or labor; parts not installed by an authorized new car dealer will be repaired or replaced without charge for parts, but labor will be the consumer's responsibility.

### WHAT IS NOT COVERED:

The replacement parts warranty does not cover any part for which proof of original installation or purchase date cannot be provided. Parts that are considered normal wear, tear or maintenance service items are not warranted unless a defect in material or workmanship is found to exist.

### OTHER TERMS:
